(Agencies with two asterisks (**)) have both firefighting divisions and auxillary divisions.)

* A firefighter responds to structure fires, brush/wildland urban interface fires, and motor vehicle accidents. When medically trained as a First Responder, EMT, or Paramedic, a firefighter may also respond on EMS calls if the agency is designated to respond with either the Sevier County Ambulance Service or the Gatlinburg Fire Department. A firefighter participates in training drills and fundraising activities as required by the agency with which they wish to volunteer.

** An auxillary member does not participate in any of the firefighting activities listed above, but may respond to any of the incidents listed above as required by the agency with which you wish to volunteer. They may assist with firefighting equipment care on scene, and assist with the aquisition of food, water/drinks on an emergency scene. They may also assist with the setup and operation of emergency shelters for victims during a natural disaster. Not all agencies have an auxillary division.

*** The Support Staff is another option for those who may not wish to become a frontline firefighter but still want to help our community and the fire department. Our Support Staff is vital to the operations of our department and help by coordinating on-scene rehabilitation (food, water, and shelter at emergencies), providing Chaplaincy services to the members and the public we serve, organizing and facilitating various committees, or you could become a mentor by helping the teenagers in the Cadet/Explorer post. These are just a few of the many functions that the Support Staff provides to our department.
